WHEREAS, the Annual Budget for Ocean Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2023 and ending December 31, 2023 has been presented before the Board of Commissioners of the Fire District at its open public meeting of November 21, 2022; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$2,769,849.00 which includes an amount to be raised by taxation of \$2,034,453.00 and Total Appropriations of \$2,769,849.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 21, 2022 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

The proposed 2023 Budget is increasing by approximately \$511,900. The major changes in the budget result from the Fire District taking over the full operation of the Emergency Medical Services in the District. All EMS revenue will be income to the District and all related expenses will be expenses of the District. In 2022, the District provided direct financial support of \$165,700 to EMS. Also, the District was awarded a \$29,000 grant under the CY 2022 American Rescue Plan - FFG Program.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

The Board is increasing the fund balance utilized by \$44,645 (27.6%) due to an overall increase in the cost of operations. The District will be taking over the operation of EMS in the District. The Board anticipates EMS billing revenue of approximately \$350,000. The Board anticipates an increase of approximately \$9,000 in Annual Registration Fees resulting from new construction within the District. The District was awarded a \$29,000 grant under the CY 2022 American Rescue Plan - FFG Program. The Board projects an increase in administrative fringe benefits resulting from increases in health care costs & pension contributions. The Board projects a \$550 increase in Election Expenses based on current year expenses. The Board projects an increase in Office Expense of approximately \$3,500 resulting from EMS operations. The Board projects approximately \$4,000 decrease in Travel Expenses based on the current year expenses. The Board projects approximately \$587,000 increase in Operations & Maintenance Personnel expenses primarily due to the additional of EMS personnel salaries & benefits. The Board projects a decrease in Insurance expense of approximately \$45,000 due to the change in insurance provider. The Board anticipates an estimated \$28,200 increase in maintenance & repairs due to increased costs & aging of equipment. The Board anticipates an approximate \$32,000 increase in materials & supplies based on increased costs & current year expenditures. The Board anticipates an approximate \$1,670 increase in fire bureau costs due to increased activity. The Board anticipates an increase of approximately \$24,000 in expense reimbursements & incentives due to anticipated increase in response incentives. The Board anticipates the addition of the following expenses related to EMS operations: Fees & Subscriptions \$6,700, Training \$2,500, Maintenance & Supplies \$32,000, Medical Supplies \$10,000, Uniforms \$3,500, Building Supplies \$25,000, Licenses & Fee \$750, and Telephones & Computers \$3,360. The Board anticipates an increase of approximately \$12,500 in the cost of Mobile Radios to upgrade & replace radios. The Board anticipates an approximate increase of \$8,000 in Specialty Equipment due to increased maintenance costs.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The proposed 2023 Budget will increase the Amount to be Raised by Taxation by approximately \$82,400, a 4.2% increase. The tax rate will increase by one-tenth of a cent from 4.4 cents per \$100 to 4.5 cents per \$100. The Board is utilizing approximately \$66,400 of the General Surplus and \$140,000 of Restricted Surplus to help maintain the tax rate. This will leave the district a surplus of approximately \$2,126,300, which exceeds the Amount to be Raised by Taxation. The proposed 2023 budget is compliant with the Levy Cap requirements. The Board utilized \$9,760 of the Levy Cap Bank to comply with the Levy Cap requirements.
