

# BOARD OF FIRE COMMISSIONERS TOWNSHIP OF OCEAN FIRE DISTRICT NO. 1

WORK SESSION  
April 4, 2011

## **CALL TO ORDER:**

The Work Session meeting of the Board of Fire Commissioners was called to order at 7:34 pm.

This meeting is being held in compliance with the "Open Public Meetings Act". Public Notice of this meeting was mailed to the Clerk of the Township of Ocean and posted at the Oakhurst Firehouse on March 2, 2011, and advertised in The Coaster and in the Atlanticville on March 10, 2011.

## **ATTENDANCE:**

The following Board members were present: Thomas Reu, James Hiers, Scott Nelson, Russell Williams and Anthony Palmisano. Fire District Administrator David Hiers, Acting Fire Marshal Chris Pujat, Fire Inspector Craig Flannigan, Maintenance/Repair Technician Michael Fiorentino and the Fire Department and First Aid Squad Officers were also present.

## **BUSINESS:**

**Palmisano** - A new Money Market and Checking Account has been opened up at Investors Savings Bank with no annual fee.

**Hiers** – The OTLL is asking for our support. The annual sponsorship is \$200.00. I would like to offer the resolution to sponsor the OTLL for the annual fee of \$200,00. Seconded by Williams. Questions? None. Roll call vote of Williams, Palmisano, Reu, Hiers, and Nelson was in favor of the resolution.

**Palmisano** – The additional First Aid supplies have been ordered. They were delivered today.

**Williams** – Dave spoke with the Township and we will have the Blue Recyclable container here at the Fire House. Please help out and use the container when you are done with a function. Don't rely on the daily people to have to clean up after you. Thanks.

**Reu** - The Bills this evening were reviewed by the Commissioners prior to the meeting and found to be OK. Copies of the bills were on the table for anyone to review. Reu offered the Resolution to pay the Bills totaling \$ 15,230.39. Seconded by Hiers. Questions? None. Roll call vote of Williams, Palmisano, Reu, Hiers, and Nelson was in favor of the resolution.

Reu – Offered the Resolution for the transfer of funds totaling \$29,000.00 to the Payroll Account. Palmisano seconded the resolution. There were no questions. Roll call vote of Williams, Palmisano, Reu, Hiers, and Nelson was in favor of the resolution.

## **Fire Officers -**

Chief Skinner thanked those who came out to support the Ocean Twp. Little League Opening Day Parade.

1<sup>st</sup> Asst. Chief Alexander said he attended the County OEM Cordinator meeting today.

Captain Nelson submitted a equipment list of needed items – Nomex Hoods and gloves.

**First Aid Officers:**

Captain Willms presented the written report which was requested by President Nelson for his upcoming meeting along with Dist, #2 with the Township Manager and the Police Chief. The report gave a detailed account of the OFAS's plan for action.

Sargeant Beringer reported that he is plnning a meeting with BS Troop #70 to go over first aid technicques. Beringer also stated that Oakhurst & Wanamassa will be on dual dispatch during the day (8-4).

**Fire Marshal** – Pujat gave his monthly report at the Work Session due to his absence at the regular meeting due to sickness. He reported 124 inspections, including 12 State Registered Establishments, revealing 98 Violations. Four investigations were conducted during the month. Fees collected for the month totaled \$ 2,369.00. Fire Marshal Pujat is working on the Fema snow grant.
