MINUTES OF
March 25, 2019

CALL TO ORDER:

The regular meeting of the Board of Fire Commissioners was called to order by Vice President Reu at 8:01 p.m. President Nelson announced that the meeting is being held in compliance with the "Open Public Meetings Act".
